International Student Financial Guarantee Form

United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student's prospective educational and living expenses while in the U.S. North Carolina A&T State University requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F1) Status. Applicants are required to submit financial documentation that equals or exceeds one full year of educational and living expenses. A Certificate of Eligibility (I-20) will not be issued until this information is provided. **An original bank statement dated within the last six months showing the total estimated funds is required in addition to this form. Bank Statements must be in English or translated into English.**

ESTIMATED EXPENSES

The amounts listed below are estimates and are subject to change without notice. Historically, total costs have increased on an average of 5-10% each year. Students can expect adjustments in the amounts listed on the Certificate of Eligibility (I-20), which will reflect estimates for the upcoming year. This estimate is based upon full time semester hours each semester for nine months. NCAT scholarships are not available to international students.
